THIS LETTER IS A REQUEST TO PLEASE POSTPONE THE HEARING OF  
FEBRUARY 20, 2008 FOR THE FOLLOWING REASONS:

1. I NEED TIME TO PROPERLY PREPARE FOR COUNCEL IN THIS MATTER BECAUSE: (1.) I JUST ARRIVED IN LAS VEGAS 2/14/08 TO FIND MY PROPERTY CRUDELY BOARDED UP; (2.) THE BOARDING UP METHOD DROVE SPIKES THROUGH ALL MY WINDOW PANES, SHATTERING ALL. THIS WILL BE COSTLY TO REPLACE; (3.) I NEVER RECEIVED ANY NOTICE THAT THE PROPERTY NEEDED SECURING (HAD I, I WOULD HAVE RESPONDED WITHIN AN HOUR, HAD THE WORK DONE WITHOUT DAMAGES, CHEAPER BY MY HANDYMAN; (4.) LATE FEES?? ONE HAS TO BE INFORMED OF AN ACTION OR DEBT, THEN WHEN THEY FAIL TO COMPLY, THE CONSEQUENCES RESULT IN A "LATE FEE".; (5.) IS THIS "NEIGHBORHOOD SERVICES" A CITY PROGRAM? OR IS IT THE STEWART TOWN ASSOCIATION TO WHICH I PAY A MONTHLY ASSOCIATION FEE TO EACH MONTH, BEING THAT THEIR DUTIES COMPRISE OF KEEPING THE GROUND UP AND KEEPING UP THE OUTSIDES OF THE UNITS. AS SUCH, THERE ARE NO TREES, GRASS, WEEDS. (6.) AS THE CITY HAS ALL THE INFORMATION IN WHICH TO CONTACT ME (AND THE ASSOCIATION) BANK, PROPERTY, ETC., PLEASE TAKE INTO CONSIDERATION THAT THIS WAS DONE WITHOUT MY KNOWLEDGE, AT AN OUTRAGEOUS PRICE AND DAMAGE TO MY PROPERTY AND THAT I WOULD LIKE TO ATTEND THE HEARING BUT CANNOT STAY AT THIS TIME DUE TO AN UNFORESEEN SHOCK AND NO PRIOR NOTICE.
