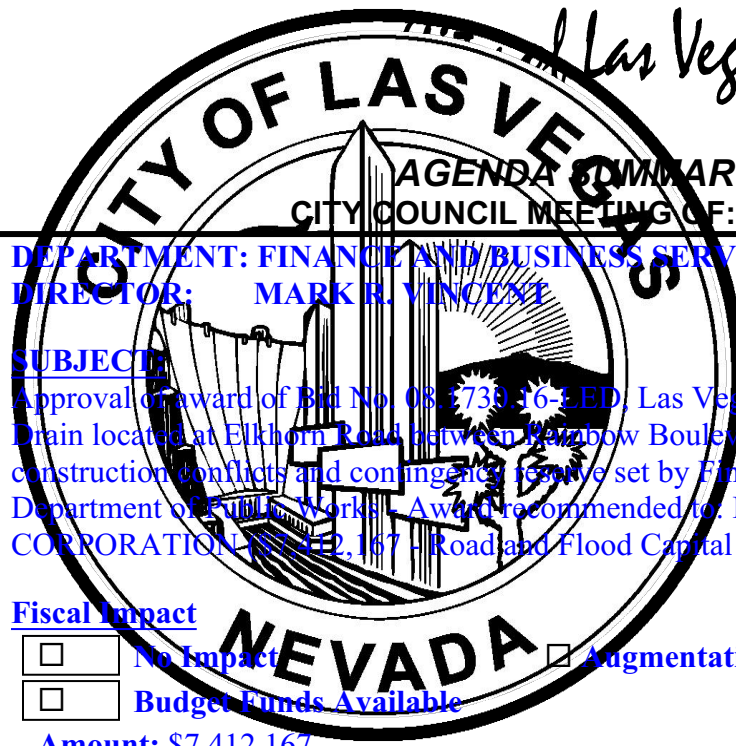

Approval of award of Bid No. 08.1730.16-LED, Las Vegas Wash Middle Branch Elkhorn Storm Drain located at Elkhorn Road between Rainbow Boulevard and Torrey Pines Drive and the construction conflicts and contingency reserve set by Finance and Business Services - Department of Public Works. Award recommended to: LAS VEGAS PAVING CORPORATION (\$7,412,167 - Road and Flood Capital Projects Fund) - Ward 6 (Ross)

PURPOSE/BACKGROUND:

The project consists of the construction of new and expanded drainage facilities consisting of double 13' x 9' RCB storm drains in Elkhorn Road between Rainbow Boulevard and Torrey Pines Drive. A 60" RCP storm drain bleeder line will be constructed in Torrey Pines Drive from Elkhorn Drive to Dorrell Lane as well as a 60" stub to the north of Elkhorn Road. Drop inlets, storm drain manholes, lateral pipes ranging from 18" RCP to 48" RCP to 76" x 48" HERCP in sizes, pipe stubs and connection to existing facilities will be constructed as part of the system as well as shallow "V" shaped drainage ditches along the south and north sides of Elkhorn Road. Funding for this project is provided by the Clark County Regional Flood Control District.
