The City Council at a regular meeting held January 18, 2006 APPROVED the request for Special Use Permit FOR A PROPOSED MIXED USE DEVELOPMENT at the southeast corner of Charleston Boulevard and Western Avenue, (APNs 162-04-505-001 and 002, 162-04-513-004 thru 162-04-513-009, 162-04-513-010 thru 162-04-513-015), M (Industrial) Zone [PROPOSED: C-2 (General Commercial) Zone]; [NOTE: The address should read at the southeast corner of Wall Street and Western Avenue.] The Notice of Final Action was filed with the Las Vegas City Clerk on January 19, 2006. Planning and Development

1. Conformance to all Minimum Requirements under Title 19.04.050 for Mixed-Use Development.
2. Approval of and conformance to the Conditions of Approval for General Plan Amendment (GPA-8892), Rezoning (ZON-8893), Special Use Permit (SUP-8895), Site Development Plan Review (SDR-8894), and Vacation (VAC-8898).
3. This Special Use Permit shall expire two years from the date of final approval, unless it is exercised or an Extension of Time is granted by the City of Las Vegas.
4. All City Code requirements and design standards of all City departments must be satisfied.
