The City Council at a regular meeting held January 18, 2006 APPROVED the request for a Special Use Permit FOR A PROPOSED CONVENIENCE STORE WITH FUEL PUMPS at the southwest corner of Tenaya Drive and Azure Way (APN 125-27-222-009), T-C (Town Center) Zone [SX-TC (Suburban Mixed Use - Town Center) Special Land Use Designation]. The Notice of Final Action was filed with the Las Vegas City Clerk on January 19, 2006. This approval is subject to:

Planning and Development

1. Conformance to all Minimum Requirements under the Town Center Development Standards Manual for a Convenience Store with Fuel Pumps use, except for the 330-foot separation distance from residential uses, which is waived.
2. Conformance with relevant Conditions of Approval for Site Development Plan Reviews SDR-5893 and Z-0076-98(20).
3. Use of a public address system is prohibited.
4. This Special Use Permit shall expire two years from the date of final approval, unless it is exercised or an Extension of Time is granted by the City Council.
5. All City Code requirements and design standards of all City departments must be satisfied.
