PURPOSE/BACKGROUND:

Wu Guo d/b/a Asian Magic holds Reflexology Establishment License No. R03-00019-H-127248 and Reflexology Practitioner License No. R11-00037-A-127248. Wu Guo was cited for performing massage without a business license, pled nolo contendere in the Las Vegas Municipal Court, and was found guilty April 11, 2007. Wu Guo d/b/a Asian Magic has operated in an illegal manner, contrary to law and in violation of LVMC 6.02.330, 6.52.040, and 6.69.130, proscribing doing business without a license, operating a massage establishment without a license, and using lotions, creams or mechanical devices in performing reflexology.

RECOMMENDATION:

Revocation of Reflexology Establishment License No. R03-00019-H-127248 and Reflexology Practitioner License No. R11-00037-A-127248
