

**INTERLOCAL AGREEMENT BETWEEN THE CLARK COUNTY RECLAMATION
DISTRICT, THE CITY OF HENDERSON, CITY OF LAS VEGAS AND
THE CITY OF NORTH LAS VEGAS**

THIS INTERLOCAL AGREEMENT, made and entered into as of the 2nd day of April, 2008, by and between the Clark County Water Reclamation District ("CCWRD"), the City of Henderson ("HENDERSON"), the City of Las Vegas ("LV") and the City of North Las Vegas ("NLV").

W I T N E S S E T H

WHEREAS, any one or more public agencies may contract with any one or more other public agencies to perform any governmental service, activity or undertaking pursuant to NRS 277.180; and

WHEREAS, the Clark County Reclamation District, the City of Henderson, the City of Las Vegas and the City of North Las Vegas (hereinafter referred to as "entities") provide sewer services to the residents of Clark County; and

WHEREAS, the Public Utilities Commission (hereinafter referred to as "PUC") has proposed new rules that, if adopted will have a significant impact on the entities; and

WHEREAS, the entities desire to be jointly represented by counsel that is experienced in the practice of law before the PUC; and

WHEREAS, the entities agree to share the cost of representation by counsel;

NOW, THEREFORE, in consideration of the covenants, conditions, contracts and promises of the parties hereto, CCWRD, HENDERSON, LV and NLV agree to the following:

CCWRD shall contact and retain the services of the law firm of HALE LANE PEEK DENNISON AND HOWARD (hereinafter referred to as "HALE LANE") to represent the parties before the PUC.

CCWRD shall receive by invoice billings and monthly accountings from HALE LANE, and pay the contracted amount within thirty (30) days of receipt of the invoice. The amount to be paid shall not exceed One Hundred Twenty-Five Thousand Dollars (\$125,000.00), unless approved by the respective governing boards of the parties to this agreement.

CCWRD shall submit to Henderson, LV and NLV a copy of the invoice and an itemized accounting as provided by HALE LANE.

Henderson, LV and NLV shall within thirty (30) days of receipt of the invoice, pay one fourth of the cost of the monthly invoice to the CCWRD.
