**PURPOSE/BACKGROUND:**

This Board is comprised of 9 members, filling three-year terms, with at least two members over the age of 60. Appointees must represent specific categories: 2 members of Senior Organizations; 2 Senior Service Providers; 3 Private Citizens; and 2 Members of the Nevada State Bar. Members are limited to two terms. Ms. Seip was a Leisure Services appointment recommendation and served as one of the members of Senior Organizations representatives. She has served two terms and is not eligible for reappointment.

Sheri Cane Vogel, Project Administrator of the Senior Citizen Law Project, recommends Ms. Marguerite Mathis be appointed to fill Ms. Seips seat.
