**PURPOSE/BACKGROUND:**

Federal regulations require that the RTC and local entities, including all member cities and Clark County, must enter into an Interlocal Contract to set forth in a written agreement their respective roles, under Federal and State law, in carrying out the metropolitan transportation planning process. The Safe, Accountable, Flexible, Efficient Transportation Equity Act, a Legacy for Users (SAFETEA-LU) and the implementing regulations of the U.S. Department of Transportation require the development of transportation plans and programs by the State and the RTC in its role as metropolitan Planning Organization (MPO) in cooperation with the cities of Southern Nevada, Clark County, and NDOT. As a part of that role the RTC must demonstrate compliance with SAFETEA-LU and Title 23 of the United States Code to remain eligible for the receipt and utilization of transportation planning grants in accordance with applicable federal law and regulation. An interlocal contract is one of those requirements. The RTC and all entities entered into interlocal contracts dated June, 1983, which was subsequently amended in January, 1989, and a second interlocal contract dated October 12, 1995, which the proposed interlocal contract will replace.
