Approval of Fourth Supplemental Interlocal Contract for design of the Oakey - Meadows Storm Drain located on the Springs Preserve site from the northwest corner of Alta Drive and Valley View Boulevard to Fulton Place, west on Fulton Place from Valley View Boulevard to Hinson Street, south on Hinson Street to Charleston Boulevard, west on Charleston Boulevard to Decatur Boulevard and south on Decatur Boulevard to Sahara Avenue (\$4,720,354 - Clark County Regional Flood Control District [CCRFCD]) - Ward 1 (Tarkanian)

**PURPOSE/BACKGROUND:**

On August 14, 2003 the Clark County Region Flood Control District approved an Interlocal Contract for design associated with the Oakey - Meadows Storm Drain. On July 13, 2006, the First Supplemental Interlocal Contract extended the date of completion to August 14, 2008. On November 9, 2006, the Second Supplemental Interlocal Contract provided funding for costs associated with right-of-way activities. On August 9, 2007, the Third Supplemental Interlocal Contract provided additional funds for the engineering design of the project. This Fourth Supplemental Interlocal Contract is requested, due to additional engineering design needed for the existing Las Vegas Creek-Meadows open channel north of Alta Drive, which discharges to the Meadows Detention Basin. This existing open channel, identified in the 2002 Master Plan as facility numbers LCME 0027 and LCME 0039, must be redesigned for additional capacity needed to perpetuate flows from the Oakey-Meadows Storm Drain.
