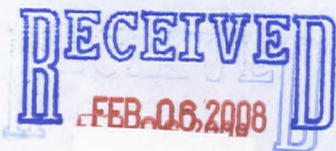

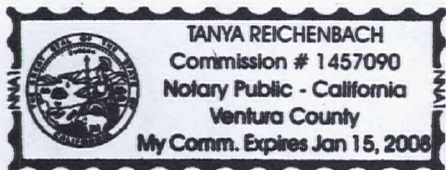

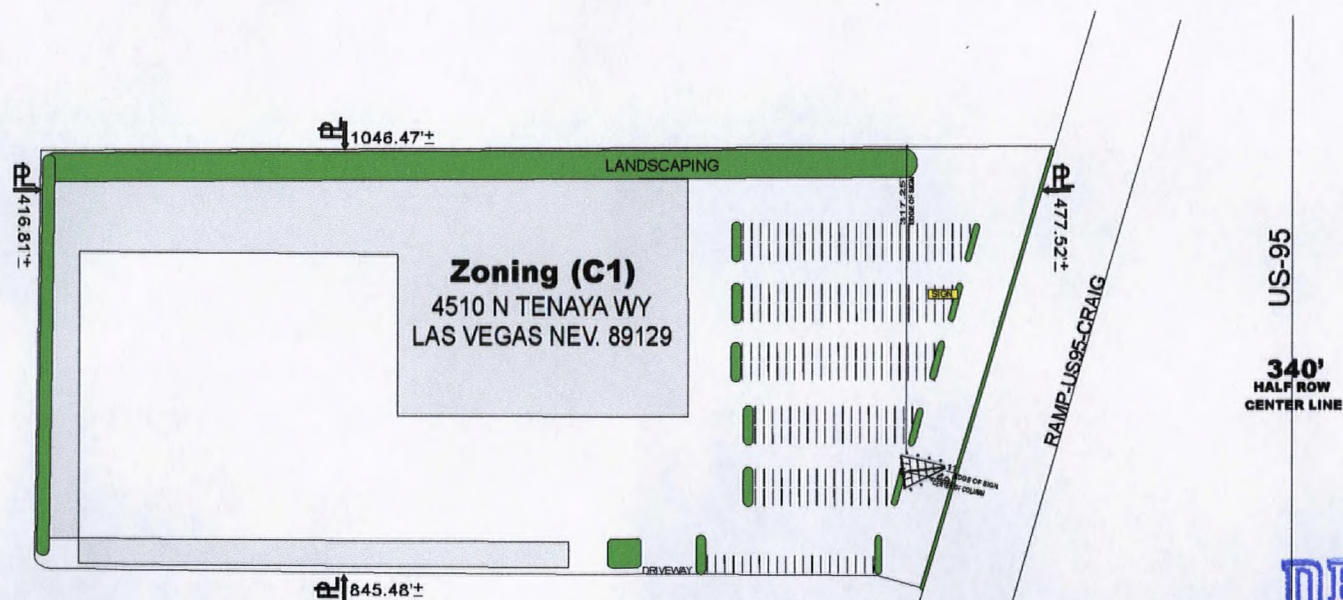


VICINITY MAP
