As owners of the adjacent property, we are writing to protest against the Special Use Permit to Mike's Liquor at 2600 W. Sahara Ave. Our property at 2300 West Sahara is a 12-story professional office building leased to U S Bank, Merrill Lynch, Chicago Title, McDonald Carano, and other professional firms. We object to the special use permit for the following reasons:

- As owners, we have always prided ourselves on maintaining the property as an A-class office building and we feel that a package store on the adjacent property would detract from that image.
- Due to the busy Sahara/Rancho traffic corridor and proximity to the freeway, we constantly struggle to keep vagrants away from the property as it is of utmost importance to us to keep the property safe for our tenants. We feel that allowing a package liquor store on the adjacent property would exacerbate an already increasing problem.
- The employees in the building, many of them women, park in a three-story parking garage adjacent to the 2600 W. Sahara property and the tenants often walk to their cars after dark. The buffered area behind the garage is an opportune hideout for derelicts and hoodlums and we are concerned that the added convenience of access to package liquor will encourage lurking and loitering behind the garage and that the tenants will be fearful of walking to their vehicles.

We encourage you to act in the best interest of the residents and businesses in the surrounding area by denying the request for the Special Use permit.



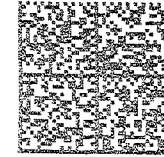

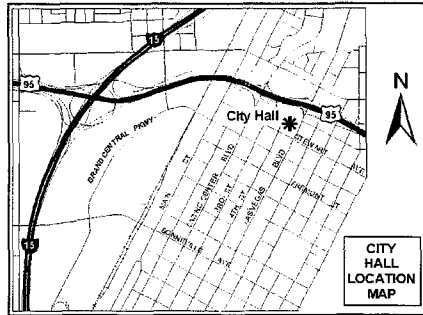
