**PURPOSE/BACKGROUND:**

This project consists of the removal, repair and reinstallation of dome covers on Sludge Thickener Plants No. 1 and No. 2; to repair and seal concrete surfaces associated with Sludge Thickener Plants; to remove and reinstall or replace odor control piping; to clean, repair and seal concrete surfaces at Primary Sedimentation Basins Plants No. 3 and No. 4; remove and dispose of old grit classifier equipment and install new equipment, piping, control wiring and power. The apparent low bidders request to withdraw its bid due to an administrative error that significantly affected the bid amount was approved by the Purchasing Manager pursuant to R-48-2006.
