As an employee with the City of Oak Park, Department of Recreation, I was directly accountable to the Recreation Advisory Board. The issues related to Seniors – recreation, education, health, transportation, nutrition, social services, travel and outreach; Teens – center programming after-school, evenings, weekends and summer; Youth Activities – summer playground, weekend drama and daycamps; and related fiscal matters as the department expanded in scope. Both my passion for recreational activities and my professional experiences, led me to realize how much I wanted to become a voice for the community in which I lived.

As an elected official in West Bloomfield Township I was directly responsible for determining policy, budget, hiring the director, and presenting to both the Town Board and public at large. 


