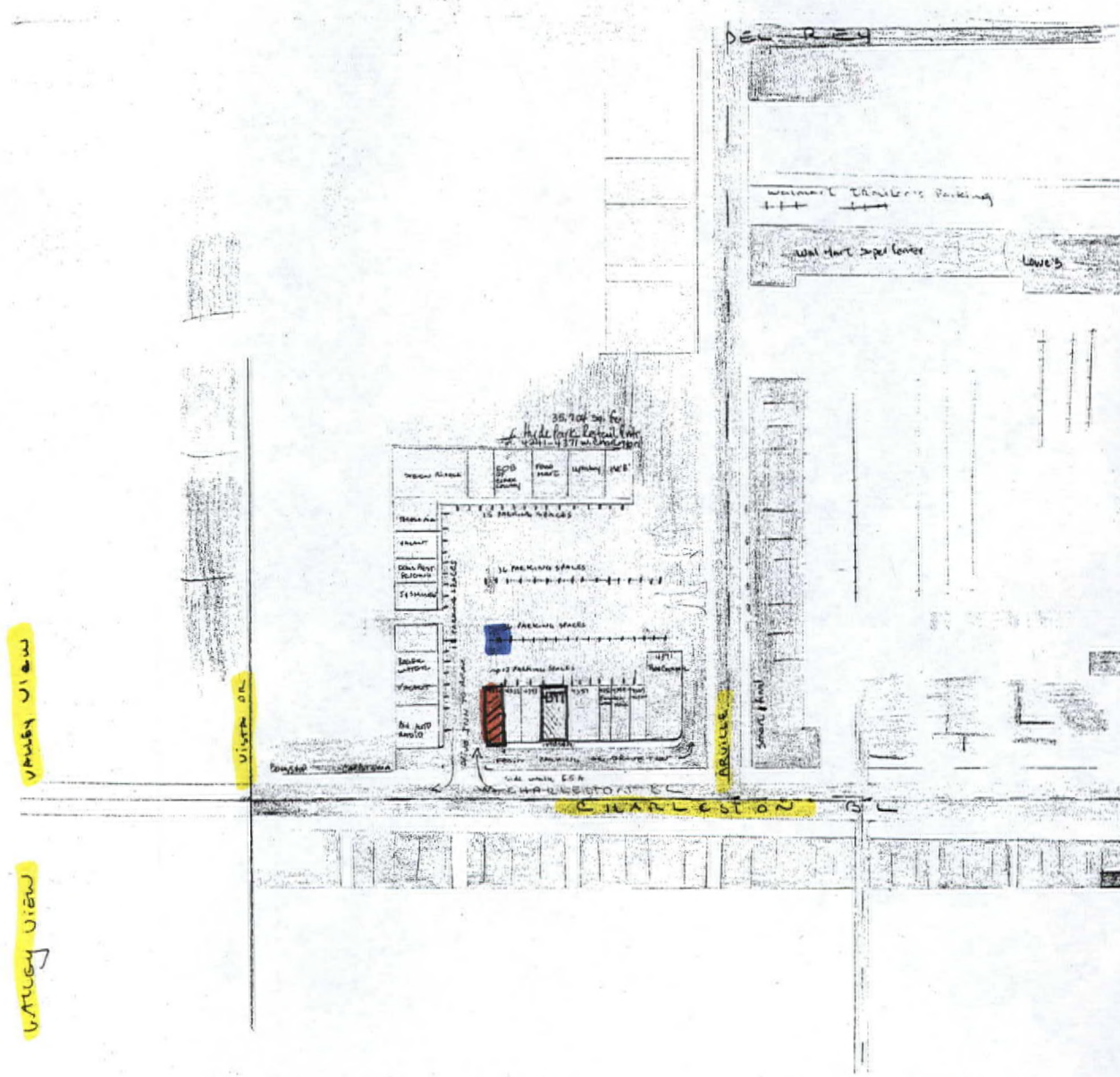

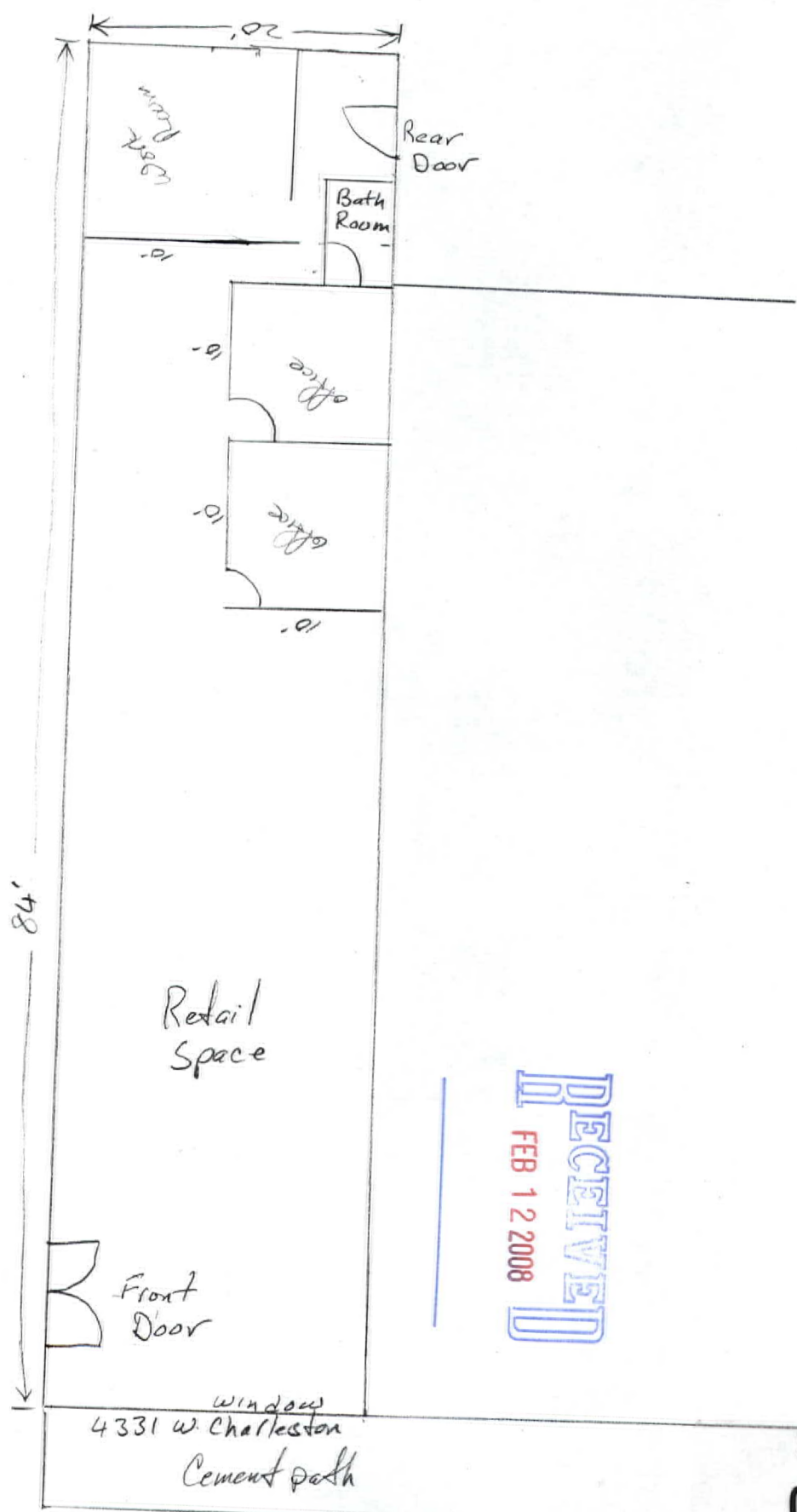
Side Plan

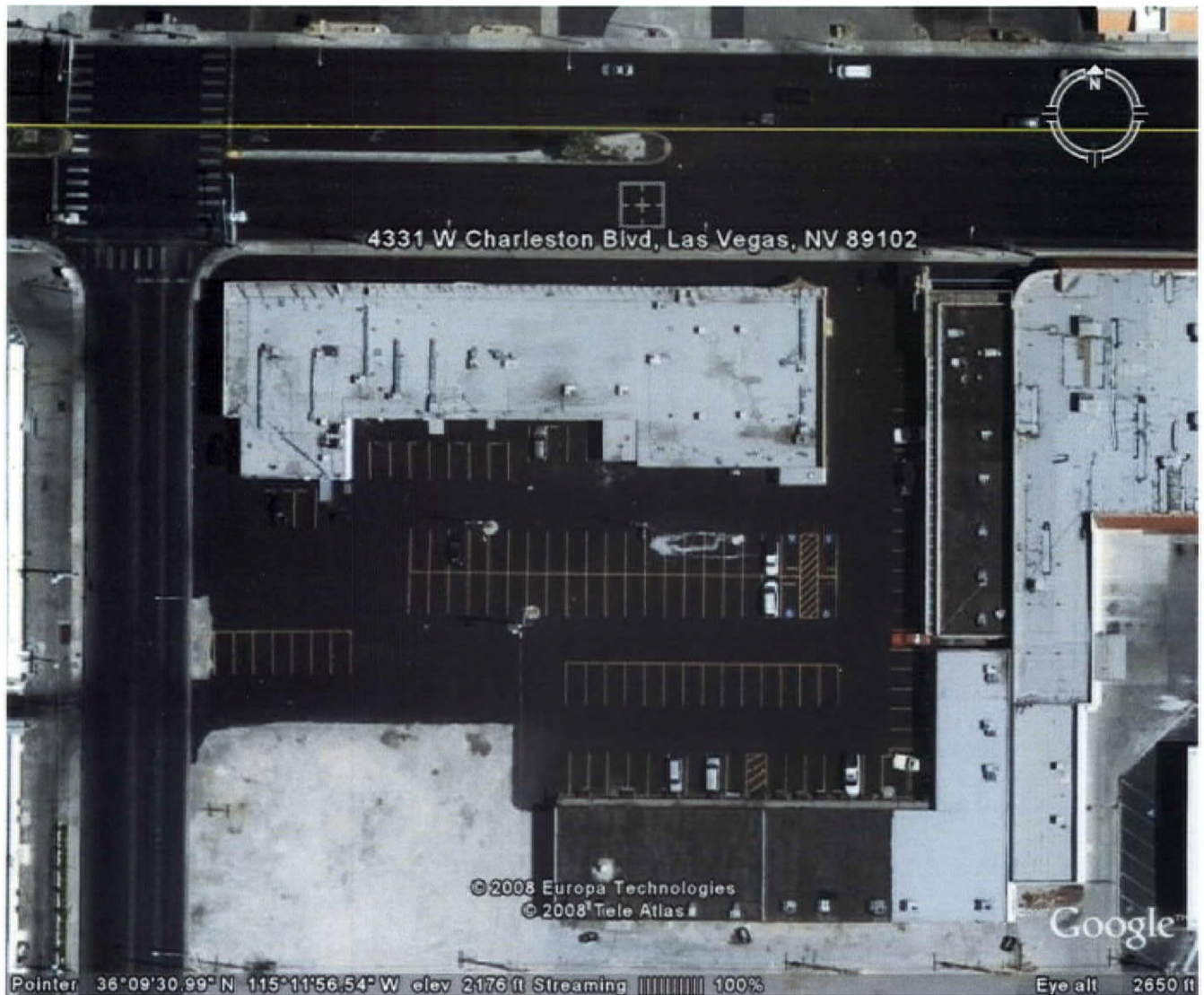
