PURPOSE/BACKGROUND:

On February 21, 2007 City Council approved the award of an Engineering Design Services Agreement for the design of the Trail Bridge Package for pedestrian bridges with tentative locations at Las Vegas Wash Trail/Lamb Boulevard crossing, Las Vegas Wash Trail/Charleston Boulevard crossing, Lone Mountain Trail/Cheyenne Avenue crossing and Lone Mountain Trail/Lake Mead Boulevard crossing. The first amendment will provide for the design of an undercrossing and trail on the south side of the Las Vegas Wash between Lamb Boulevard and Washington Avenue. The funding for this project is being provided by the Southern Nevada Public Land Management Act (SNPLMA), Round 6. This item is exempt from the competitive bidding process pursuant to NRS 332.115.1(b), Professional Services.
