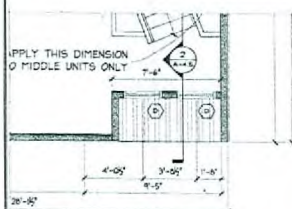
3rd FL. PLAN W / INDENTATION WALL



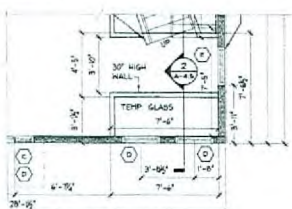

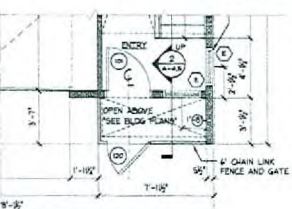
1st FLOOR PLAN W / INDENTATION WALL



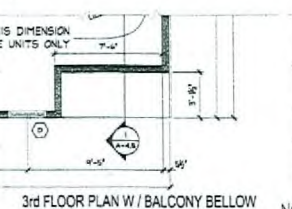
3rd FLOOR PLAN W / RECESS WALL

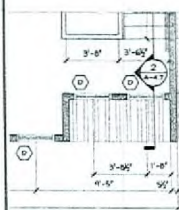

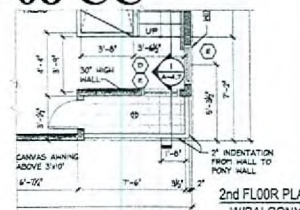

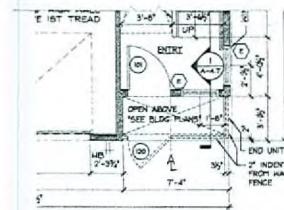
