ALSO, ALL BLOCKS FIVE (5) AND SIX (6) OF SAID SUNRISE PARK TRACT NO. 1.

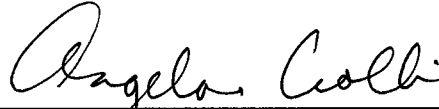
