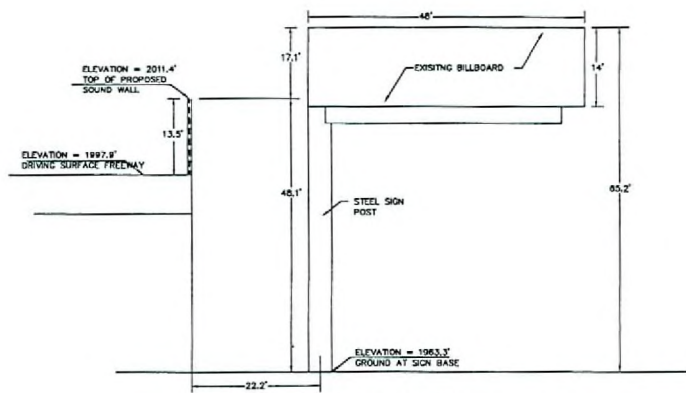

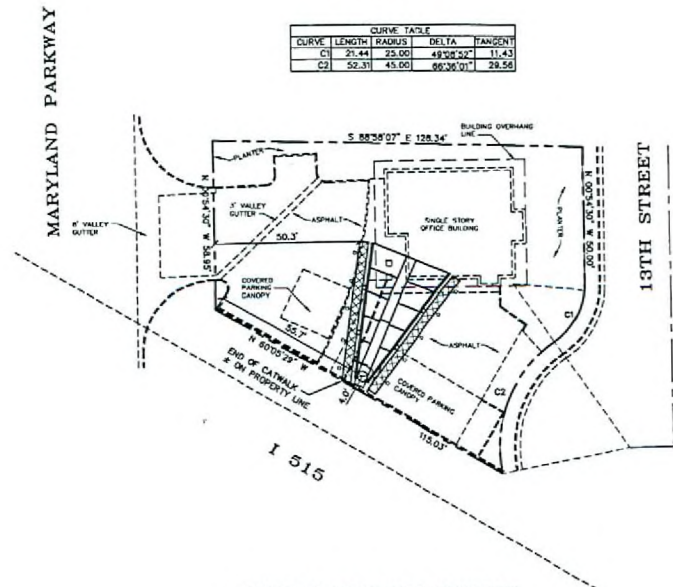

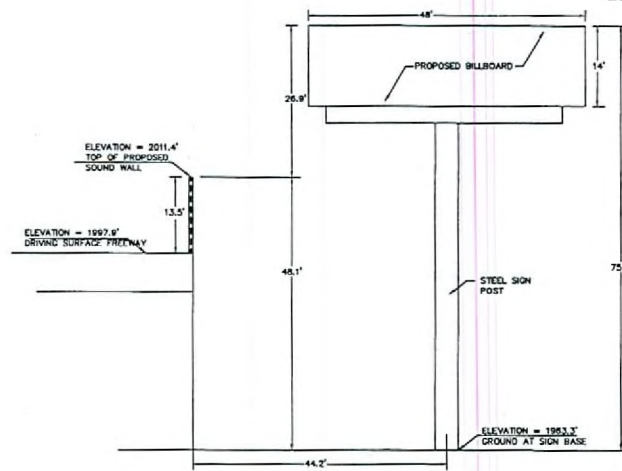


ELEVATION DETAIL

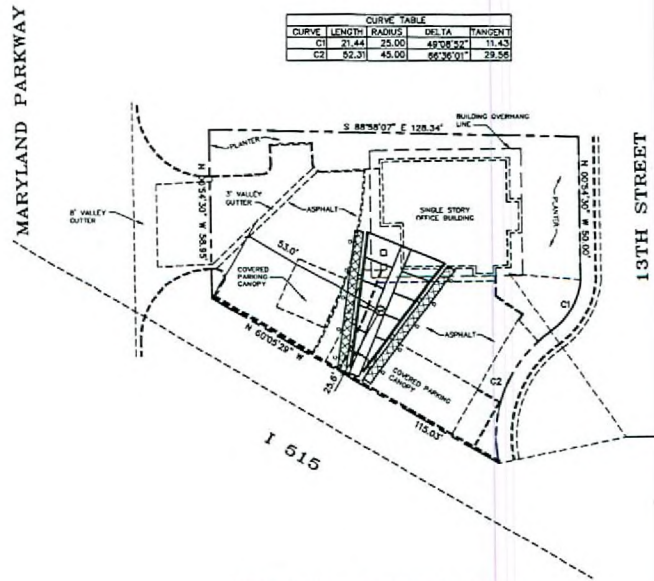


EXISTING BILLBOARD LOCATION

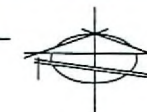
