Minutes:
CHAIR GOYNES declared the Public Hearing open.

MARGO WHEELER, Director of the Planning and Development Department, stated that this text amendment had been present to the Commissioners and was held to address concerns regarding the possibility of allowing unoccupied buildings within the Casino Overlay District to be wrapped for advertising purposes.

COMMISSIONER STEINMAN requested clarification of the definition for LEED signage and MS. WHEELER explained that the text amendment does not contain a definition, but the term is defined by the US Green Building Council. COMMISSIONER TRUESDELL suggested that text amendment referred to LED signage and MS. WHEELER confirmed that the reference to LEED was a typo.

PLANNING COMMISSION MEETING OF: JUNE 12, 2008

MS. WHEELER informed COMMISSIONER EVANS that an unoccupied casino could be completely wrapped for signage. COMMISSIONER EVANS suggested that previous submission of the text amendment was better than the current version and noted that the City has no way to regulate content. MS. WHEELER agreed that the City could not control content, but could control the quality of the wraps, the fabric of the wraps and how they are attached to the building.

In response to COMMISSIONER STEINMANN'S question, MS. WHEELER explained that the casino use runs with the site and is not related to building occupancy.

MS. WHEELER confirmed for COMMISSIONER TRUESDELL that non-framing structures that were not occupied would not be permitted to be wrapped.

CHAIR COYNE declared the Public Hearing closed.
