# 45. Bill No. 2008-25 which "eliminates the requirement that a general business-related gaming establishment (which is) licensed to sell alcoholic beverages obtain a separate special use permit for the gaming use.

We note with interest the peripheral establishment of numbers of slot machines per square feet of usable floor space, etc.

Section 3: line 3 cannot be allowed to muddy the definition of GENERAL BUSINESS.

GAMING and an ALCOHOLIC BEVERAGE LICENSE are NOT and CANNOT be labeled as 'General Businesses' -such is false.

Please **vote NO** on this Bill No. 2008-25 which attempts tragedy.

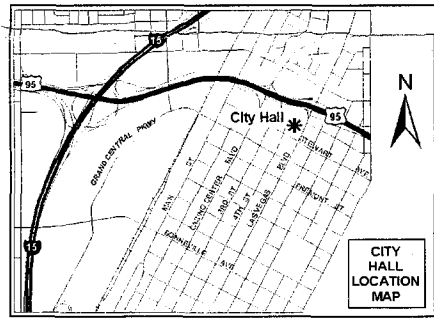
