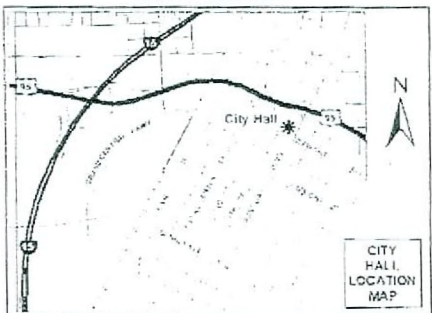

Comments: Even though the facilities are direly needed to accomodate Las Vegas growth, I feel that placing 4 facilities in this location would make it a light industrial area which does not blend with the existing neighborhoods.

The heavy truck traffic, which would be adding to the existing gravel pit trucks, is a concern. Regarding hours of operation, Republic Services is planned to operate from 6pm to midnight and the Detention Center would 24 hours a day. This would increase the night-time noise and light pollution in an area that boarders rural communties and the foothills recreation area.

I am also concerned about the increased trash and debris that will come from the trash trucks en route to and from the facility. Recently, there was a story on the local news that highlighted the amount of trash along the I-15 corridor to Apex. This would be our in our future.
