PURPOSE/BACKGROUND:

This agreement provides for a pre-project planning study for a future trail facility located within a 45-acre regional open space corridor located northwest of Alexander Road and Cliff Shadows Parkway. The study will identify trail alignments and will include a minimum of two functional and varied design alternatives along with one design provided by the City. Also included is geotechnical investigation, grading analysis, representation at public meetings and other tasks related to the feasibility and conceptual design of the project. Staff will use this strategic information to address risk and feasibility of option, determine costs and commitment of resources, preparation of funding applications and planning for subsequent project phases. This item is exempt from the competitive bidding process pursuant to NRS 332.115.1(b), Professional Services. Funding is being provided by the Southern Nevada Public Land Management Act (SNPLMA).
