PURPOSE/BACKGROUND:

On October 12, 2007 the Purchasing and Contracts Manager approved, pursuant to Resolution 48 -2006, the award of a Designated Services Agreement for Special Inspections and Material Testing associated with the Jaycee Park Renovation project in the amount of \$47,112. The first amendment provides for additional special inspections and material testing work in the restroom, bocce and horseshoe pit areas. This item is exempt from the competitive bidding process pursuant to NRS 332.115.1(b), Professional Services. Funding for this Amendment is provided by the Southern Nevada Public Land Management Act (SNPLMA).
