Minutes:

JIM DiFIORE, Manager of Business Services, stated that an investigative report was completed and although there were no business license code violations during that six-month period, the contents of the report have caused concern as the applicant had not disclosed the requested information. MR. DiFIORE added that during a subsequent interview, MS. LE once again omitted the information requested on the application.

MR. DiFIORE recommended an extension of the Temporary License with an additional review at the end of that period to ensure MS. LE is in compliance with all Business Licensing code regulations.

CITY COUNCIL MEETING OF: JUNE 18, 2008

COUNCILMAN WOLFSON asked for clarification on the location of the salon. MR. DiFIORE replied that this is an ancillary part of the salon. With regard to the license itself, MR. DiFIORE confirmed that there have been no complaints but that the issue arose when MS. LE failed to answer the application questions truthfully. COUNCILMAN WOLFSON requested MR. DiFIORE sit with the licensee to explain the contents of the investigative report.

MR. DiFIORE discussed and explained the areas of concern with MS. LE. She acknowledged that she understood those areas of concern. MS. LE stated that she feared she would not be approved and therefore omitted vital information. COUNCILMAN WOLFSON accepted her explanation.
