The Planning and Development staff shall approve the exact design of the Monopalm, prior to issuance of building permits.

Minutes:

MAYOR GOODMAN declared the Public Hearing open.

WILLIAM DALEY, 100 Amigo Court, Las Vegas, appeared and stated that Metro PCS has been working with COUNCILWOMAN TARKANIAN regarding the design of the tower. The tower will now be 70 feet and stealth, and up to three carriers can utilize the tower.

MARGO WHEELER, Director of Planning and Development, confirmed for COUNCILWOMAN TARKANIAN that with the changes to the design, Condition 1 would be amended and there would be an additional condition. She read them into the record and clarified for the Councilwoman that the 70 foot requirement is from the top of the palm and, as she requested, the applicant will use the Date palm. MS. WHEELER read an additional phrase to the added condition to address the Councilwoman's concern to ensure the proper model is selected.

MAYOR GOODMAN declared the Public Hearing closed.
