#27 (a Consent Resolution) Which we respectfully request to be REMOVED from the CONSENT status until an affirmation has been made public that the protestants know of this Resolution AND approve of the disposition of these protests.

45. Bill No. 2008-25 which "eliminates the requirement that a general business-related gaming establishment (which is) licensed to sell alcoholic beverages obtain a separate special use permit for the gaming use.

We note with interest the peripheral establishment of numbers of slot machines per square feet of usable floor space, etc.

Section 3: line 3 cannot be allowed to muddy the definition of GENERAL BUSINESS.

GAMING and an ALCOHOLIC BEVERAGE LICENSE are NOT and CANNOT be labeled as 'General Businesses'—such is false.

Please **vote NO** on this Bill No. 2008-25 which attempts tragedy.

#62 SUP-27536 Please **vote a resounding NO** for this 61 ft .WAIVER of distance from an ELEMENTARY school, in fact a pair of Elementary schools.
