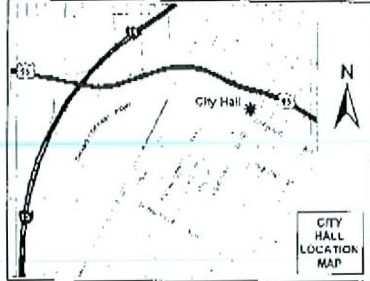
Please deny this request. It is too close to our Sacre park and houses. Our homes are very close together and there are many children walking to and from school. Please think of the children.

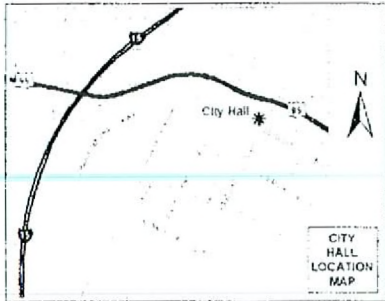

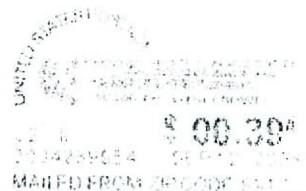
