
Subject: Lee's Discount Liquor

Dear Mayor ~~Goodman~~ ^{OSCAR}:

The City of Henderson Police Department conducted a background investigation as a prerequisite to the issuance of a business license requested by Mr. Hae Un Lee, owner of Lee's Discount Liquors. Mr. Lee successfully completed this process and no concerns were uncovered to cause the City of Henderson to reject his application for the license. Mr. Lee was granted a business license for Lee's Discount Liquor and there are now two locations operating within the City of Henderson – 4427 E. Sunset Road and 10935 S. Eastern Avenue.

In reviewing the calls-for-service at the two Henderson locations, I did not find Lee's Liquor to be at fault in any of the minor disturbance calls nor those related to criminal activity. Based on this review, the Henderson Police Department finds Lee's Discount Liquor to be a responsible packaged liquor license operator and business within the City of Henderson.

The North Las Vegas Police Department conducted a background investigation based on a package liquor business license by Mr. Hae Un Lee. Mr. Lee successfully passed this process and no matters of interest were found to reject his application. Lee's discount liquor obtained a business license and has been in operation since that time.

In reviewing the Calls For Services at his current location in North Las Vegas only one call for service was generated, as of this letter's date, and it was not related to criminal activity.
