JIM DiFIORE, Manager of Business Services, introduced DETECTIVE REINNIK who will be the City's Liaison for the Metropolitan Police replacing DETECTIVE TONI WEEKS.

CITY COUNCIL MEETING OF: AUGUST 6, 2008

MAYOR GOODMAN expressed his appreciation to DETECTIVE WEEKS for her service while working with the City.

DETECTIVE BARRY REINNIK said that one of the applicants had an undisclosed criminal history, including a misdemeanor bench warrant in Colorado. When this was brought to his attention, MR. McNULTY removed MR. COOPER'S name and made it appear that the business would be a sole proprietorship. However, MR. COOPER'S ownership of the location made it obvious to LVMPD that MR. COOPER would remain involved in the business behind the scenes.

MR. McNULTY rebutted that MR. COOPER was removed from the business pursuant to a clause in the partnership agreement requiring the parties to pass licensing requirements. He is working on relocating the business to another site or to his residence.

MR. DiFIORE said that documentation still lists MR. COOPER as a resident agent, compounding the City's concern. He suggested abeying the item for two weeks to allow proof of the alleged changes.
