MAYOR GOODMAN declared the Public Hearing open.

MATT CONNOLLY, Venture Corporation and RON PORTARO, 6108 Iron Kettle Street, appeared on behalf of the applicant. MR. CONNOLLY stated they held a neighborhood meeting at the request of COUNCILMAN ROSS. MR. PORTARO added that there was discussion about restricting the hours of deliveries to 7:00 a.m. until 8:00 p.m. However, his client had requested the hours of 6:00 a.m. to 10:00 p.m., and in the event any problem arose, they would come back for a review of condition.

MR. PORTARO verified for COUNCILMAN ROSS that during the neighborhood meeting, the residents had expressed the desire to have deliveries from 6:00 a.m. to 8:00 p.m. COUNCILMAN ROSS indicated that this same project in 2006 has hours associated with the entire project. He appreciates the applicant being amenable with the neighborhood, and he does not see a problem granting the applicant's request regarding the delivery hours.

MARCO WHEELER, Director of Planning and Development, verified with COUNCILMAN ROSS that the delivery hours will be from 6:00 a.m. until 10:00 p.m., seven days a week.
