I have been notified of the Public Hearing for the above noted Special Use Permits. It appears that the property is currently zoned P-R Professional Office. The current land use does not allow the restaurant use that is proposed, much less the increased intensity of a night club. The zoning allows for "low intensity administrative and professional offices." The purpose of the zoning is to "decrease the impact to adjacent residential uses." The Use Permit to increase the intensity above that of a supper club is clearly and dramatically outside this vision. The location of this parcel is not compatible for the proposed use and see no other course of action by Staff and the elected official but to recommend denial of the Special Use Permits.
