Minutes:

MAYOR GOODMAN declared the Public Hearing open.

MICHAEL CORDERO, Wet Paint Media, stated he found a location that complies with the zoning map and the Code, which is on Charleston Boulevard. It is strictly a business area that is

appropriate for a billboard. At the Planning Commission, a gentleman opposing the billboard stated that it would block the Huntridge Theater sign. MR. CORDERO presented a photograph showing that that is not the case. He verified for COUNCILMAN BARLOW that the theater sign is located west of the proposed billboard.

COUNCILMAN REESE stated the residents do not want the sign, as this area is already cluttered with signs. If it were up to him, he would ask that all signs be taken down and then establish a uniform sign plan along this corridor. This sign is not appropriate or compatible with the area.

MAYOR GOODMAN declared the Public Hearing closed.
