MAYOR GOODMAN declared the Public Hearing open for Items 132 and 133.

## CITY COUNCIL MEETING OF: August 06, 2008

RAYMOND CORDOVA appeared on behalf of his granddaughter and thanked the Planning Commission and City Council for allowing this business to open. Massage is only one portion of the spa, which has other amenities making it a great addition for the City. He showed a photograph of the building today, its interior and the ambiance of the place and he explained the different types of spas. It is an affordable spa, and he asked that the 24-hour operation be granted.

COUNCILMAN WOLFSON verified this is the location of the old Las Vegas Athletic Club, and that it is open to the public by appointment.

MR. CORDOVA clarified for COUNCILWOMAN TARKANIAN that the applicant is requesting a waiver to allow a 24-hour spa.

BEATRICE TURNER, West Las Vegas, stated that this type of spa would be good for people who have severe arthritis and it should be open 24 hours.

COUNCILMAN REESE invited all Council members to tour the facility; it is one of the nicest spa facilities he has seen. The service they provide is extraordinary. The restricted hours were imposed due to concerns from the neighbors because of the massage component. However, he now feels comfortable lifting those conditions.

MARGO WHEELER, Director of Planning and Development, explained that the applicant properly requested the review of two conditions, but due to staff error, it was missed. Efforts will be made to place it on the next Council agenda.

MAYOR GOODMAN declared the Public Hearing closed for Items 132 and 133.
