PURPOSE/BACKGROUND:

This project provides for the construction of traffic signals at the intersections of Gowan/Tenaya and Alexander/Tenaya, interconnect and fiber optic cable installation on Alexander from Durango to Rainbow and on Tenaya from Gowan to Alexander. It also provides for street rehabilitation on Tenaya between Atwood and Gowan, slurry seal and striping on Tenaya from Cheyenne to Alexander and a bike lane on Tenaya from Buckskin to Craig and on Gowan from Pioneer to approximately 500 feet east of Tenaya. Partial funding for this project in the amount of \$205,946.92 is being provided by the Regional Transportation Commission.
