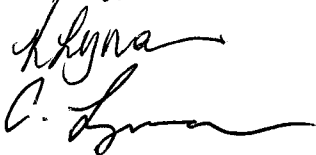
To Whom it may concern:

I understand that the Wolf Creek community would like gates in this development . I would like to **oppose this request** for the following reasons:

1. Currently traffic routes from Jones to Chestnut run to Canyon Ranch to middle of Delonee Skies Ave. Chestnut run and Canyon Ranch are the only streets in the Wolf Creek community where there is traffic. These two roads are lined by fences where traffic travels with the exception of two homes. If this fence to create the cul-de-sac is put in place, traffic would be rerouted through the neighborhood at Jesse Hill and down Yamamoto effecting 20-25 homes.
2. Traffic is slowed down as it enters the neighborhood due to the turns that need to be made to make its way to the middle of Delonee Skies Ave. If the traffic is re-routed speeding will be an issue on Delonee Skies Ave since cars will travel the entire length of Delonee Skies Ave this will effect another 20+ homes.
3. Currently there are two points of entry into our neighborhood. By putting up gates into Wolf Creek this would limit the points of entry to one. This would be done because of the 60 homes in Wolf Creek. However there are 120+ homes for the rest of the neighborhood.

Please reconsider putting these gates in.
