Dear Council Members:

Our home is located in Wolf Creek sub division on the north east corner of Amber Station Ave. & Canyon Ranch as indicated by the red X on the enclosed post card.

A large portion of the residents located on or north of Brent Ln. use Chestnut Run and Canyon ranch as a short cut to their subdivision. (See yellow highlighted area on post card). They could use Jesse Hill Ave. off of Jones which is the entrance to their subdivision. There is no shortage of ammo because of the desert landscaping. A couple of months ago we ended up with 3 bicycles in our back yard. Someone through them over the fence. Thank God no one was standing in the line of fire. I was concerned that maybe the bikes were stolen so I called the Police Department and they sent two officers out in two separate patrol cars. I am sure they had something more important to tackle.
