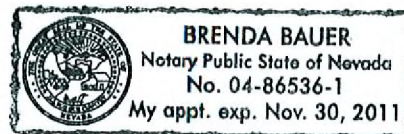

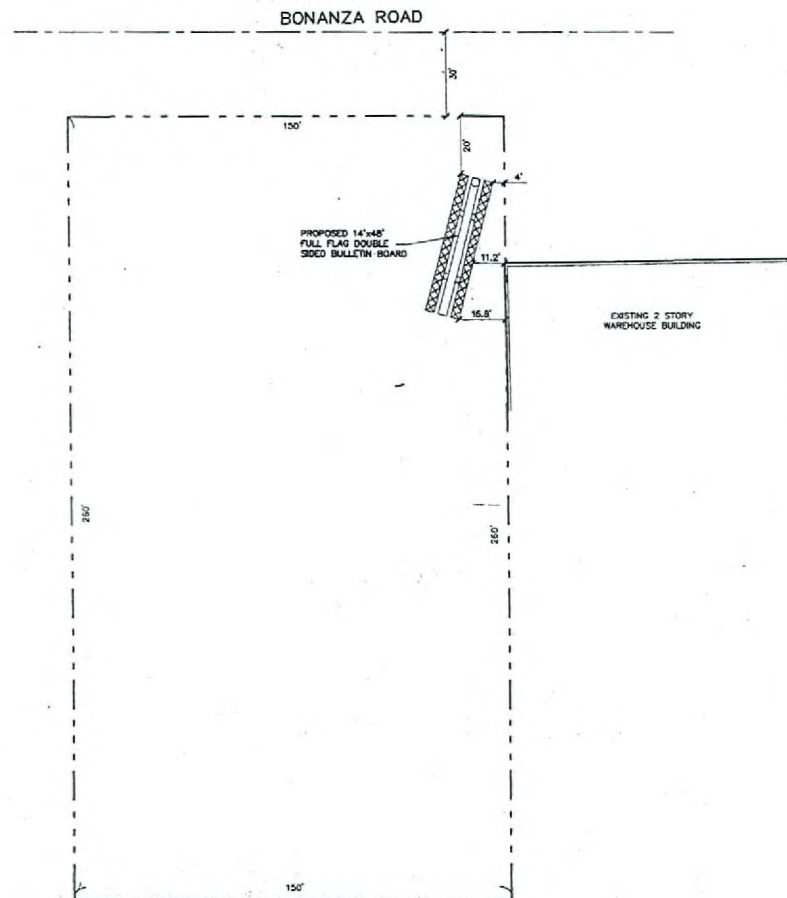

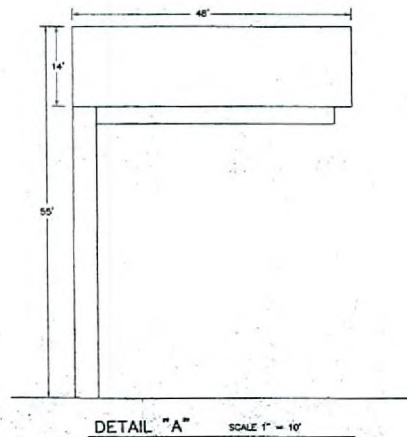
**OFF-PREMISES SIGNS

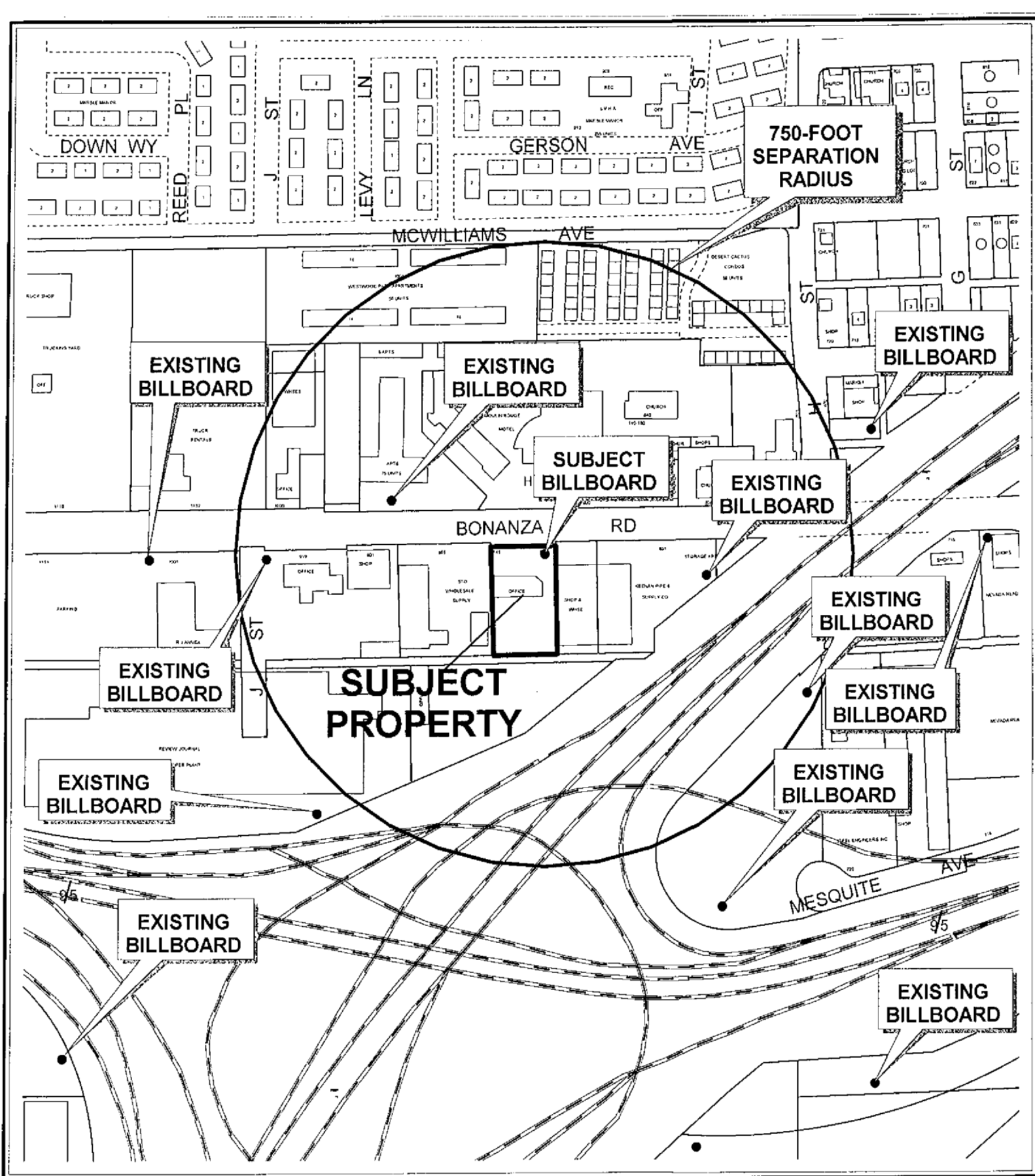
- STREET CENTERLINE
