**PURPOSE/BACKGROUND:**

On September 20, 2006 City Council approved Agreement No. 070066-DC to provide design services for the Brent Lane and Tule Springs detention basins located in Floyd Lamb State Park. On May 16, 2007, Mod. No. 1 was executed to incorporate additional owner requested design changes. Mod. No. 2 represents additional design work to include waterline and sewer relocation, structural design of concrete structures, abutments for three prefabricated trail bridges, flood warning signs, trail design and other related design services. This item is exempt from the competitive bidding process pursuant to NRS 332.115.1(b), Professional Services.
