PURPOSE/BACKGROUND:

The Community Development Recommending Board reviews all Community Development Block Grant and other funding sources and makes recommendations to the City Council on the applicants eligible to receive these funds. Members of this board either reside or work in the City of Las Vegas and are appointed by the Mayor and City Council. On September 3, 2008, the City Council approved the Sixth Amended and Restated By-Laws which reduced the total number of members from 24 to 13. Members represent target neighborhoods and populations, including low-income, disabled, minorities, elderly and the community at large. The previous 24 member board expired July 3, 2008 and in accordance with the new by-laws, a 13 member board must now be appointed. The term of office is nine-months with no limit to the number of terms that may be served.
