**PURPOSE/BACKGROUND:**

This project provides for street improvements on Tenaya Way from Westcliff Drive to Washington Avenue and includes curb and gutter, sidewalks, medians, bridge structure, pedestrian underpass, storm drain, street lights, sanitary sewer and traffic signals, plus 1350 linear feet of a shared-use path, to include decomposed granite, landscaping, concrete path, fencing, signage and other related work along Tenaya Way. Funding for this project is funded by Southern Nevada Public Land Management Act and Regional Transportation Commission.
