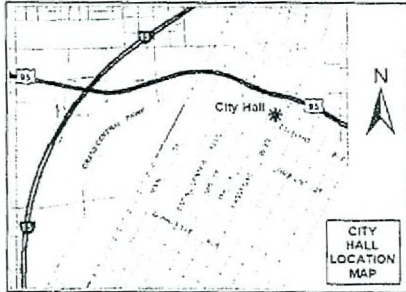

First I would like to thank the members of the commission for allowing me to speak before them.


