Minutes:

JIM DiFIORE, Manager of Business Services, reported that the applicants meet the criteria for consideration of a temporary approval of change of ownership for this license. He recommended approval of a temporary license with conditions including no retail sales of long guns or hand guns.

ATTORNEY MAREN PARRY, 100 City Parkway, Suite 1750, appeared with CRAIG McCALL, Pawn Plus and Pawn Place, and KENNY ALWINE, Territory Director of Operations, EZ Pawn, 39 Vista Del Mar Street. She explained that EZ Pawn currently has three locations within the city, and MR. McCALL plans to be involved only as a consultant. ATTORNEY PARRY respectfully requested approval.

COUNCILMAN BARLOW confirmed with MR. ALWINE the acceptance of the condition prohibiting the sale of long guns or hand guns.
