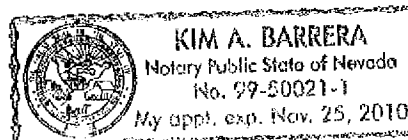

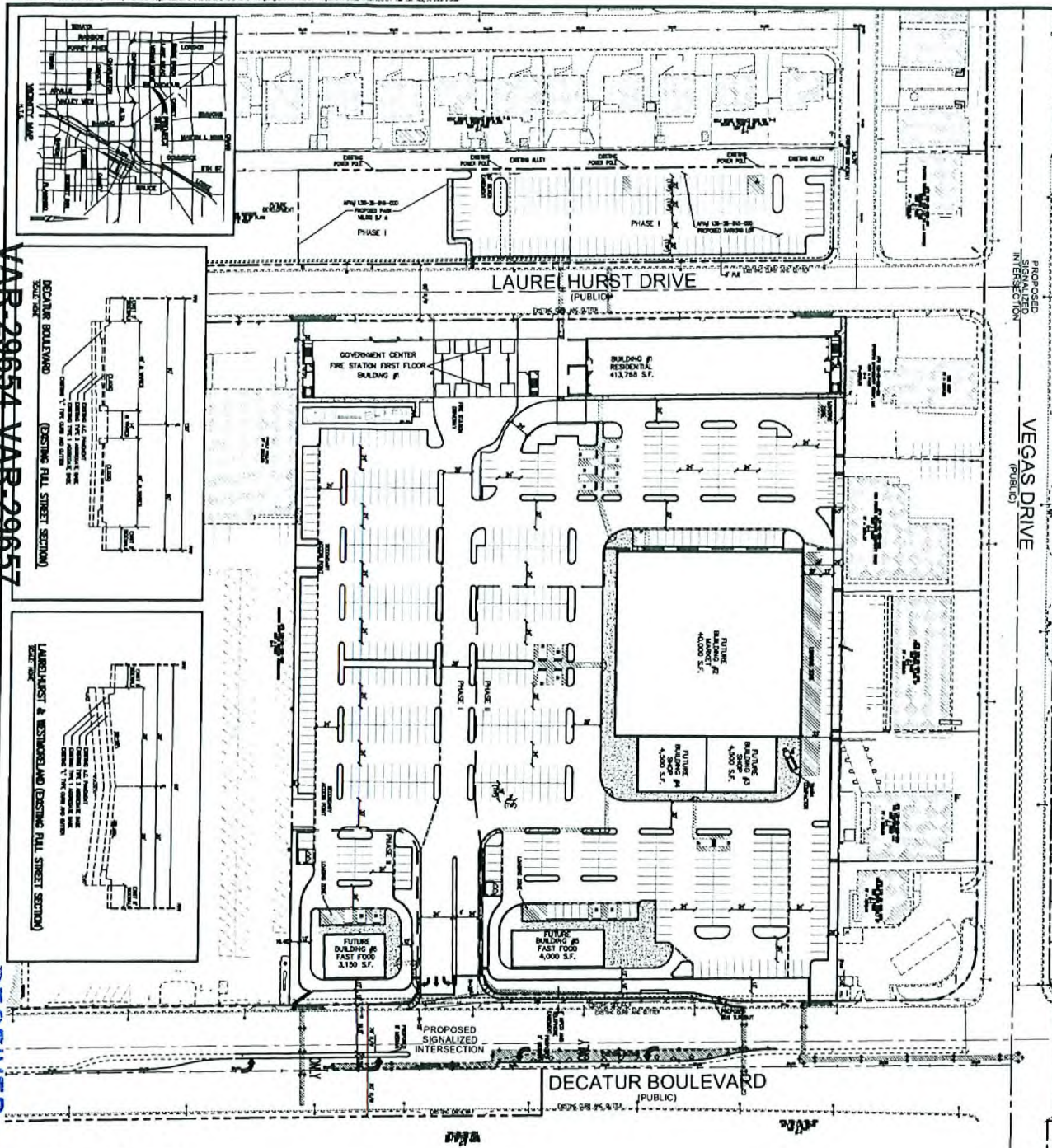


**DECATUR BOULEVARD (DASTING FULL STREET SECTION)**
