**PURPOSE/BACKGROUND:**

This project provides for construction of approximately 13,600 linear feet of a multi-use trail, a trail head and a pedestrian bridge. The work consists of clearing and grubbing, grading and paving, pedestrian lighting, fences, gates, barriers and bollards, trash receptacles, dog waste stations, signage, ADA-accessible sidewalk ramps, landscaping and related project activities. Funding for this project is being provided by the Southern Nevada Public Land Management Act (SNPLMA).
