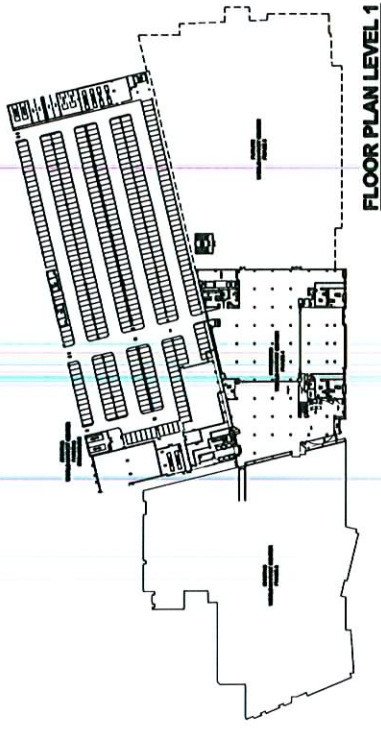

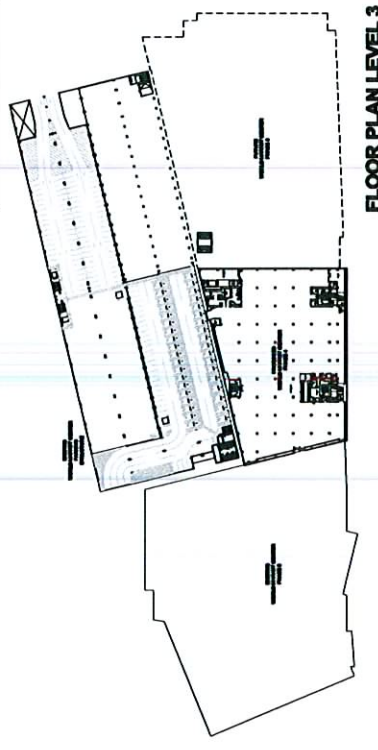

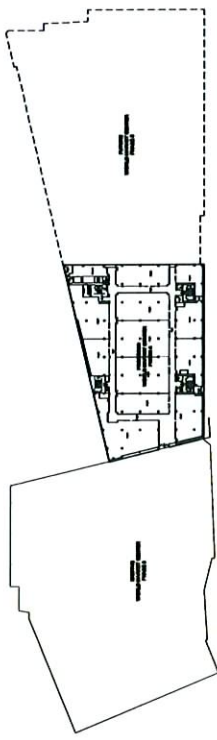
FLOOR PLAN LEVEL 1



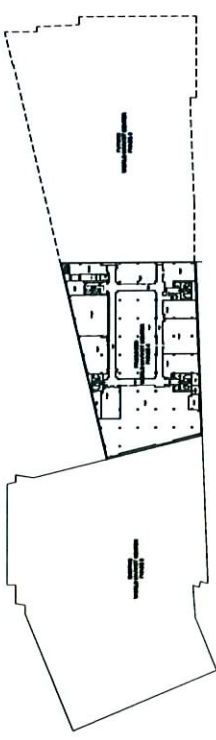
FLOOR PLAN LEVEL 3

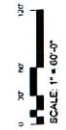
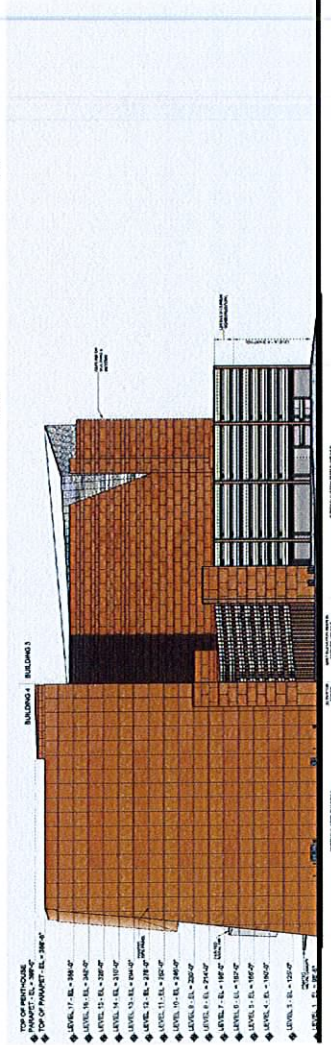
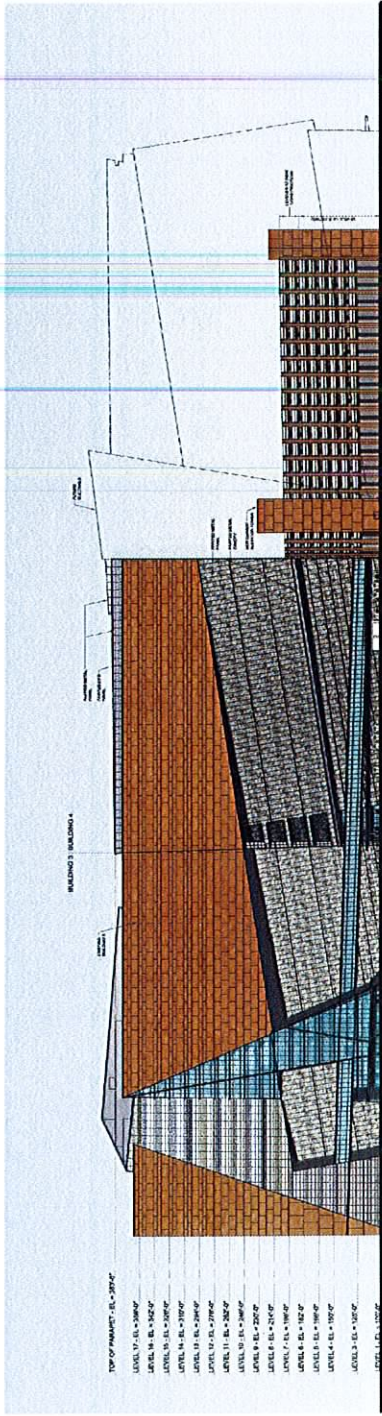
TYPICAL FLOOR PLANS

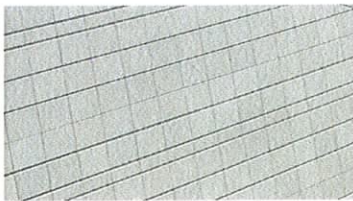
