Summary: Revises the composition of the City
Arts Commission relative to the City's
representation thereon.

7 **THE CITY COUNCIL OF THE CITY OF LAS VEGAS DOES HEREBY ORDAIN**
8 **AS FOLLOWS:**

9 **SECTION 1:** Title 2, Chapter 34, Section 30, of the Municipal Code of the City of
10 Las Vegas, Nevada, 1983 Edition, is hereby amended to read as follows:

11 **2.34.030:** The membership of the Arts Commission shall be as follows:

12 (A) Three members appointed by the Mayor;

13 (B) One member appointed by each of the City Councilmen;

14 (C) Two members appointed by the members who are appointed pursuant to
15 Subsections (A) and (B) of this Section; and

16 (D) [The Director of Leisure Activities,] One member representative of City staff,
17 appointed by the City Manager, or a designee, who shall serve ex officio.

18 **SECTION 2:** If any section, subsection, subdivision, paragraph, sentence, clause or
19 phrase in this ordinance or any part thereof is for any reason held to be unconstitutional or invalid or
20 ineffective by any court of competent jurisdiction, such decision shall not affect the validity or
21 effectiveness of the remaining portions of this ordinance or any part thereof. The City Council of the
22 City of Las Vegas hereby declares that it would have passed each section, subsection, subdivision,
23 paragraph, sentence, clause or phrase thereof irrespective of the fact that any one or more sections,
24 subsections, subdivisions, paragraphs, sentences, clauses or phrases be declared unconstitutional,
25 invalid or ineffective.
