PURPOSE/BACKGROUND:

The committee shall consist of five members to represent the residential construction, commercial development and construction industries, a public officer of the City who manages the fiscal affairs of the City, and a public officer of the Department of Building and Safety who oversees directly the operation of the Enterprise Fund. Appointments are recommended by the City Manager and approved by the City Council. Terms are for two years; no limit to the number of terms, with no City Residency requirement. Robert W. Potter is the CEO and Principle of Affordable Concepts, Inc.; on the Board of Directors for the Association of General Contractors (AGC); LV Board of Realtors; and Chamber of Commerce organizations for Henderson, North Las Vegas and Las Vegas; with expertise in public relations, advertising, budgeting, contracts and job production; and he is a qualified candidate to fill the Commercial Development Industry vacant seat. Chris Knight, Director of Building and Safety is recommended by the City Manager to fill the Public Officer vacant seat.
