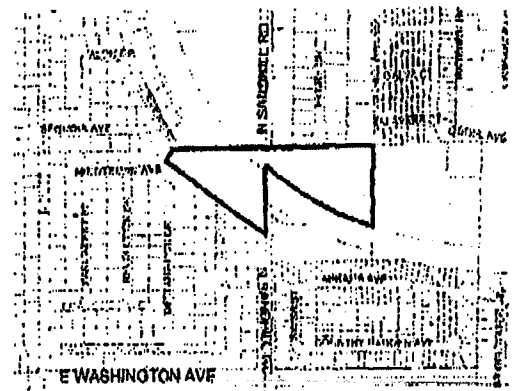

The proposed project may not pertain to the entire highlight project site.

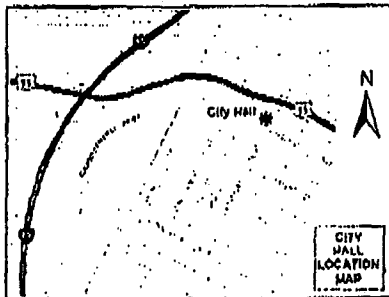

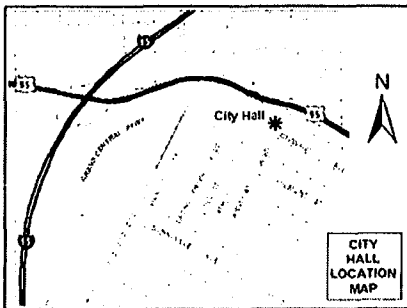

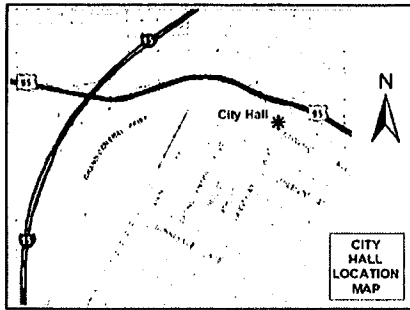
