

**SUPPLEMENTAL INTERLOCAL CONTRACT
BUS TURNOUT PROJECT-FISCAL YEAR 2007**

THIS SUPPLEMENTAL INTERLOCAL CONTRACT, made and entered into this 4TH day of MARCH, 2008, by and between the City of Las Vegas, a municipal corporation, hereinafter referred to as the "CITY", County of Clark, a political subdivision of the State of Nevada, hereinafter referred to as the "COUNTY" and the Regional Transportation Commission of Southern Nevada, hereinafter referred to as the "RTC".

WITNESSETH

WHEREAS, pursuant to Chapter 373 of the Nevada Revised Statutes, a Project for the design and installation of bus turnouts including right-of-way acquisition, construction of bus turnout, passenger loading pad, ADA accessibility, utility relocation, retaining walls, landscaping, sign relocation, driveways relocation, storm drain drop inlets relocation along Lamb Boulevard, and at the Pecos Road and Bonanza Road intersection, located wholly within the CITY, has been approved by the RTC.

WHEREAS, the parties have executed an interlocal contract dated February 8, 2007; and

WHEREAS, the CITY wishes to extend the project completion date.

NOW, THEREFORE, in consideration of the covenants, conditions, agreements, and promises of the parties hereto, the RTC authorizes the CITY to proceed with the PROJECT as it is mutually understood and agrees as follows:

SECTION III – GENERAL paragraph 7 shall be revised to read as follows:

7. The project must be completed to the satisfaction of the RTC prior to March 31, 2012.

RTC may at any time thereafter grant time extensions or terminate this Contract and require all sums advanced to the CITY be reimbursed.

The remainder of the Interlocal Contract dated February 8, 2007 shall remain unchanged.

IN WITNESS WHEREOF, this Supplemental Interlocal Contract is effective as of the date first set forth above.
