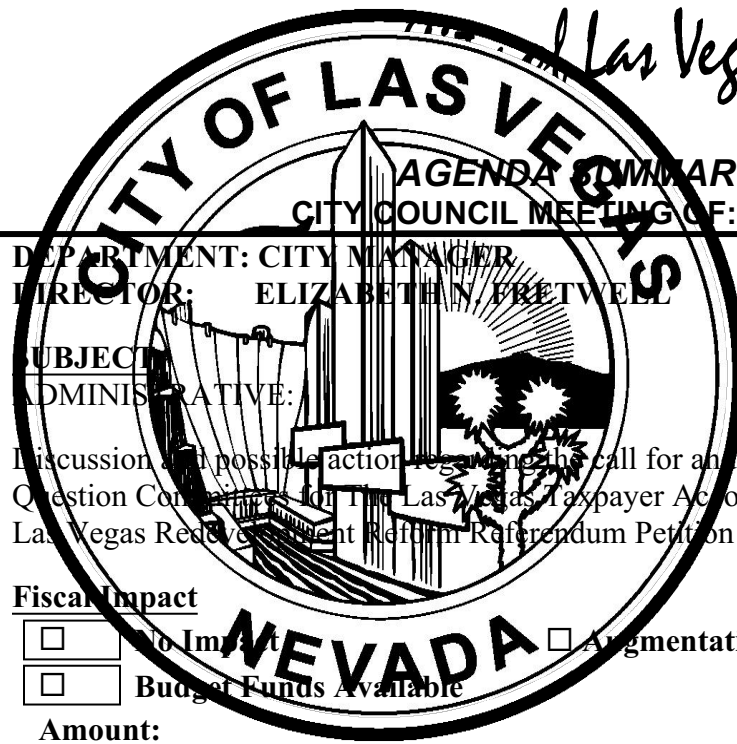

PURPOSE/BACKGROUND:

On January 22, 2009 two Petitions were filed with the City Clerk to have two questions placed on the 2009 Municipal General Election Ballot; The Las Vegas Taxpayers Accountability Act Initiative and The Las Vegas Redevelopment Reform Referendum. Both petitions were deemed to have a sufficient number of signatures on February 10, 2009. Per NRS 295.217, Ballot Question Committees need to be appointed to prepare arguments advocating and opposing approval of the Ballot Questions; one Advocacy Committee for each Ballot Question and one Opposition Committee for each Ballot Question for a total of four committees.

RECOMMENDATION:

It is recommended that the City Council appoint at least one and no more than three individuals to serve on each of the four Committees.
